

Write-In: To vote for a write-in candidate, write the person's name on the line provided and darken the oval.
Judges for the judicial ballot appear on the back of the ballot, columns two and three.

Partisan Offices

Instructions:

For Straight Party Voting

To vote for all candidates from a single party, fill in the oval in front of the party name. Not all parties have nominated candidates for all offices. Marking a straight party vote does not include votes for nonpartisan offices, judges or questions.

Straight Party Voting

Vote for no more than one party.
