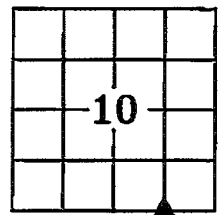

No certificate of record. This corner was used for a plot of survey in the NE 1/4 of the SE 1/4 of Section 10.



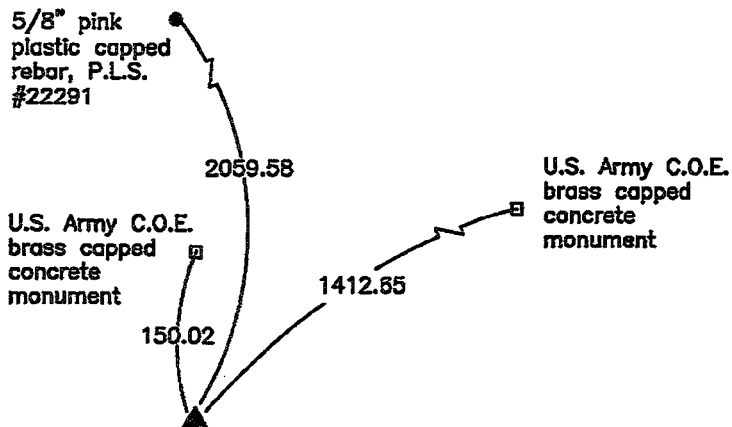
PLAN VIEW
